**Consignment Contract**

- KBC acts as an agent only and is not responsible for buyer/seller error or misunderstanding.
- Dogs will be sold as registered only if the pedigree and transfers are furnished to KBC before the sale. If the consignor wants to sell the dog as registered they must supply the papers at the time of consignment or the dog will be considered grade and sold as such.
- The commission will be 8% of the selling price, or the minimum, whichever is greater, of \$50. Consignor has the privilege to no sale or pass out their dog. If the dog is passed out, \$50 of the consignment fee will be held to cover costs as a no sale fee.
- All consignments must go through the sale ring. Consignor agrees to not privately sell or withdraw consigned dog to sale unless injured or sick with vet release. A \$150 never offered fee will be charged to the consignor if no vet release is provided. This is a contract; you are consigning your dog to sell at the sale.
- KBC and their employees will not be responsible for any injury to or loss of any animal or accidents thereby or any injury or loss of life to any participants or spectators during the sale event.
- KBC reserves the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions, or differences in regard to the sale. All consignors will be held to the terms and conditions of this contract whether or not you have read them.
- The law of the state of Idaho shall govern the interpretation of any and all disputes or other matters relating to the sale. The consignor agrees to pay any and all reasonable attorney's fees and costs incurred by KBC or its employees in the commencement or defense of any actions. Venue and jurisdiction of any and all disputes which may arise by virtue of the auction sale shall be in the court of Nez Perce County Idaho.
- Sale proceeds will be mailed on Wednesday March 28<sup>th</sup> 2018.
